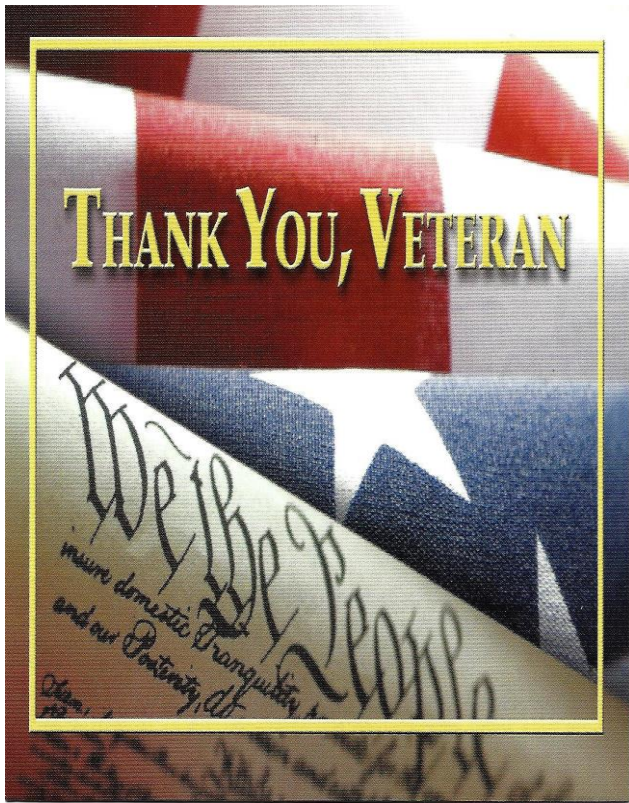

“GRAND DAME” SHOOTING MATCH (Lady Janice Beasley). I was very pleased to win Second Place. Also, I brought bumper stickers (some Confederate) – everyone is welcome to have them.

STATUE OF JEFFERSON DAVIS (Compatriot Dave Schmitt). Went to the formerly named Forrest Park in Memphis, TN. The park has been renamed by the City Council. The Forrest Statue for now is still standing in place.

CAMP POLO SHIRTS (Compatriot J. C. Gideon). Will be available/ready for pickup at the May meeting.

FORMAL PROGRAM – Southern Claims Commission (SCC) presented by Compatriot Bob Herr.



The SCC was created to satisfy loyal Southerners to the Union for what the Union destroyed and robbed them during the war. Bob's Great-Great Uncle, Martin Knobel, was one of these claimants. He submitted claim #4419 and was from Mississippi.

On March 3, 1871, the SCC held a three-man board. This board required witnesses to support each claim.

From the National Archives, Bob obtained info on Martin's claim, and each submission contained a petition, deposition, the agent, and witnesses of loyalty. His witnesses were himself, Nelson Gill, Edward Holman, and Nathan Hill. His property was raided three times, and his losses included livestock, pottery, etc. The SCC gave him \$696. Don't know if he was actually paid because there is no record of a money draft.

There was a two-year timeframe to file claims. A total of 22,298 claims were filed – in excess of \$68M. Several thousand claims weren't filed. As many as 220,000 witnesses gave written testimony. It took nine years to close the claims.

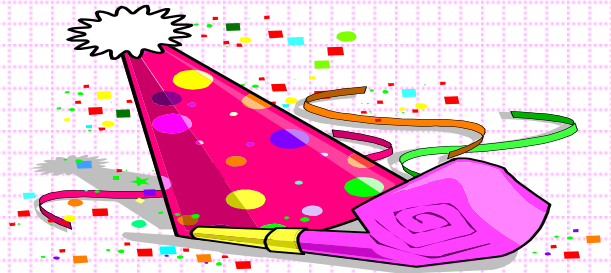
